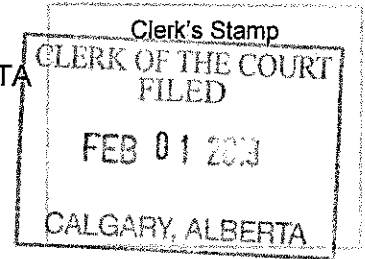

TO: The Plaintiffs, Altius Royalty Corporation, Genesee Royalty Limited Partnership, and Genesee Royalty GP Inc.

TAKE NOTICE THAT pursuant to Rules 3.61(1), 13.6(2), 13.6(3), and 13.7 of the *Alberta Rules of Court* and the *Proceedings Against the Crown Act*, RSA 2000, c P-25, s. 20, the Defendant, Her Majesty the Queen in Right of Alberta ("**Alberta**"), requests that the Plaintiffs, within 10 days of service of this Request for Particulars, provide particulars for the following paragraphs of the Amended Statement of Claim filed December 19, 2018:

1. **Paragraph 12(a)** – Specify:
 - a. From whom Genesee Royalty Limited Partnership acquired the alleged royalty interest.
2. **Paragraphs 15 and 16** – Specify:

- a. Who are the parties to the 24 April 2014 Second Amended and Restated Genesee Coal Mine Dedication and Unitization Agreement, as amended.

3. **Paragraphs 40 and 41** – Specify:

- a. The content of each alleged statement or representation;
- b. When each alleged statement or representation was made;
- c. Who made each alleged statement or representation;
- d. To whom each alleged statement or representation was made;
- e. How each alleged statement or representation was made, and
- f. If in person, where each alleged statement or representation was made.

4. **Paragraph 43** – Provide particulars as to the benefits that Alberta is alleged to have obtained.

AND TAKE FURTHER NOTICE THAT in accordance with Rule 3.61(2), Alberta demands that the requested particulars and information be provided within 10 days, failing which it will seek an Order that the requested particulars and information be provided, with costs.
